CALL FOR APPLICATIONS FOR THE ADMISSION TO 1ST LEVEL AND 2ND LEVEL ADVANCED PROFESSIONAL COURSES OF THE 2020-2021 ACADEMIC YEAR

DECREES

Art. 1 - GENERAL PROVISIONS

This call for applications includes the provisions governing the admission to 1st and 2nd level Advanced Professional Courses of the 2020-2021 academic year, as per Enclosure 1.

The **Highlights**, the **Educational activities** and the **Enrolment procedures** of each Advanced Professional Course are available on their relating webpage at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>.

Art. 2 – GENERAL ADMISSION REQUIREMENTS

The 1st and 2nd level Advanced Professional Courses are exclusively open to candidates holding a bachelor's degree, a first-level academic diploma or any other suitable title of study got abroad and deemed as equivalent pursuant to the Educational regulations in force.

The 2nd level Advanced Professional Courses are open to candidates holding a degree achieved according to the old academic system (before Ministerial Decree no. 509/99), a master's degree, a second-level academic diploma or any other suitable title of study got abroad and deemed as equivalent pursuant to the Educational regulations in force.

For the Faculty of Medicine, the 1st level Advanced Professional Courses are also open to candidates holding the qualifications referred to in art. 1, paragraph 10, of Legislative Decree no. 402 of November 12, 2001, converted into law no. 1 of January 8, 2002.

With regard to specific admission requirements, the **Educational activities** of each Course, available at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>, shall apply.

Art. 3 – ORGANISATION AND ATTENDANCE TO EDUCATIONAL ACTIVITIES

The Advanced Professional Courses usually have a one-year duration. The educational activities amount to overall 1,500 hours, out of which at least 300 consist in taught lectures. The remaining hours may be devoted to other educational activities such as internships, seminars, conferences and conventions focusing on topics pertaining to the same subjects of the Course, to individual study and to prepare the final exam.

The annual educational schedule of the Advanced Professional Courses and the number of credits acknowledged for each educational activity are available on the webpage of each Course at www.uniroma1.it/it/pagina/elenco-dei-master.

Attendance to the educational activities is mandatory and must be evidenced by means of the candidates' signature.

Usually, failure to attend more than 25% of the overall lecture hours entails non-admission to the final exam and non-achievement of the diploma.

In case of non-attendance, poor results, non-regularity of payments or any kind of misconduct, the Scientific

Educational Board of the Advanced Professional Course may suspend or exclude students. In such cases, enrolment fees will not be refunded.

Art. 4 - NUMBER OF AVAILABLE PLACES

All the Advanced Professional Courses are restricted access courses. The maximum and minimum number of candidates who can be admitted to each Advanced Professional Course are indicated in the **Highlights**, available on the webpage of each Course at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>.

Art. 5 - REGISTRATION ON INFOSTUD AND SUBMISSION OF DEGREES

To take part in the call for applications, candidates must comply with the following procedures, under penalty of exclusion:

- obtain a Sapienza ID number and password by registering on Infostud 2.0 at www.studenti.uniroma1.it/phoenixreg/#/; candidates already having an ID number and password do not have to register again, but only use their own credentials; in case they forgot them, they may retrieve such credentials at www.studenti.uniroma1.it/phoenix/#/recuperaPassword;
- **enter, in their Infostud personal profile, the degree held**, useful to be admitted to the Advanced Professional Course (after logging in to Infostud, they must click on "Profile" and then on "University degrees").

Art. 6 - PAYMENT OF FEES FOR THE ADMISSION TEST/QUALIFICATION ASSESSMENT

Candidates must mandatorily pay the \in 51 fee for the admission test/qualification assessment (\in 35 for tuition fees and \in 16 for stamp duty virtually paid), under penalty of exclusion, within h. 8:30 p.m. of January 15, 2021. Payment is due even for the qualification assessment only.

Payment must be exclusively made by using the customised form to be printed out from Infostud 2.0 according to the following procedure:

- log in to Infostud with the ID number and password from www.uniroma1.it/it/pagina-strutturale/laureati;
- select, in the following order: Advanced Professional Courses Admission to Advanced Professional Courses - enter the ID code of the course of choice (available in Enclosure 1 of this call for applications) – Continue - Print.

After printing out the form from Infostud, payment must be made at Unicredit bank according to the procedures indicated at <u>www.uniroma1.it/it/pagina/come-pagare</u>.

Payments made according to modalities other than those prescribed, and any complaints lodged for payments made beyond the above deadline, will not be accepted; candidates are therefore advised to complete the procedure ahead of deadline so as to enable the competent offices to ensure any support in case of need.

On no account will the fees for the admission test/qualification assessment be refunded if the Advanced Professional Course were not activated, except for the € 35 amount. The stamp duty will not be refunded either.

Art. 7 - SUBMISSION OF THE APPLICATION FORM AND DOCUMENTS FOR ADMISSION

Candidates must submit, **within January 15, 2021** and according to the **Enrolment procedures** available on the webpage of each Course at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>, the following documents:

- APPLICATION FORM as per Enclosure 2, duly filled-in and undersigned;
- copy of a valid identity document (identity card, driving licence, passport);
- copy of the payment receipt of the € 51 fee for the admission test;
- curriculum vitae.

Candidates holding a foreign degree, in addition to the above, shall submit one of the following documents:

- a Declaration of Value issued by the Italian Embassies or Consulates of the country in which the degree has been achieved, together with the transcript of records and a copy of the degree or
- CIMEA Statement of Comparability together with CIMEA Statement of Verification (which can be downloaded by accessing CIMEA platform at <u>www.cimea.it/it/servizi/attestati-di-comparabilita-ecertificazione-dei-titoli/attestati-di-comparabilita-e-di-verifica-dei-titoli-diplome.aspx</u>) or

• the Diploma Supplement (if it is an EU degree) issued by the university of origin and legalised by the Italian Embassy or Consulate of the country in which the degree has been achieved.

Candidates submitting an incomplete documentation will be conditionally admitted and cannot complete their enrolment until submission of all the required documentation.

Non-EU citizens residing abroad must abide by the interdepartmental provisions of the circular called "Procedures for entry, residency and enrolment at higher education institutions for students requiring visas for higher education courses in Italy, for the academic year 2020-2021" available at www.studiare-initalia.it/studentistranieri/".

Candidates who must obtain a student visa have to submit an online pre-enrolment application at www.universitaly.it/index.php/dashboard.

Candidates with a recognised disability pursuant to art. 3, paragraphs 1 and 3, of law no. 104 of 1992 and/or having a disability equal or higher than 66% must submit:

• a copy of the certificate attesting their disability issued pursuant to the law, under penalty of exclusion from the reliefs provided for; the same certificate must be also forwarded to the Office for Students with disabilities and Specific Learning Difficulties to the following email: sportellodisabili@uniroma1.it.

Applications with incomplete documentation or submitted according to modalities other than those provided for by the **Enrolment procedures** of each Advanced Professional Course at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>, or submitted beyond the prescribed deadline, will not be accepted.

In case of shipment by post, the stamp of the competent Administration Offices, rather than the shipment date, will be proof of such shipment. Candidates who choose such submission method take the risk of any late delivery.

Art. 8 – SELECTION PROCEDURE

To be admitted to the Advanced Professional Course, candidates must hold one of the academic qualifications (as per art. 5 of this call for applications) indicated among the admission requirements of the **Educational activities** of each Course, available at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>.

For some Advanced Professional Courses, any additional qualifications/experience included in the CV might be also assessed.

Should an admission test be required, it will be carried out in accordance with the procedures and deadlines indicated in the **Enrolment procedures** of each Advanced Professional Course at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>.

Art. 9 – PUBLICATION OF THE LIST OF SUCCESSFUL CANDIDATES

Upon completion of the qualification assessment and of the admission test, if any, the list of successful candidates will be published on the webpage of each Advanced Professional Course. The publication of the list of successful candidates is deemed as being a service for all intents and purposes.

Should the number of candidates exceed that of the available places, candidates will be included in a special list and only the successful ones will be admitted to the Advanced Professional Course; the other eligible candidates will be admitted only in case of withdrawal of one or more successful candidates.

Art. 10 - PAYMENT OF TUITION FEES

Candidates admitted to the Advanced Professional Course must pay the first instalment or make a one-off payment of the tuition fees as indicated in the **Enrolment procedures** of each Course within the mandatory deadline of **February 15, 2021.**

To make payment, candidates must exclusively use the customised form to be printed out from Infostud 2.0 according to the following procedure: log in to Infostud with the ID number and password from <u>www.uniroma1.it/it/pagina-strutturale/laureati</u>, select, in the following order: Advanced Professional Courses - **First year** - enter the **ID code of the course of choice** – Continue - Print.

After printing out the form from Infostud, payment must be made at Unicredit bank according to the procedures indicated at <u>www.uniroma1.it/it/pagina/come-pagare</u>.

In case a list of successful candidates were published, in compliance with art. 10, paragraph 1, of the Regulations, the students admitted to the Advanced Professional Course who fail to pay the first instalment of tuition fees within **February 15, 2021** will be charged an additional fee of \in 65 for late payment; should the first instalment be paid 60 days after **February 15, 2021**, the due additional fee will be equal to the double of the standard tuition fees.

In case a special list of qualified candidates were published in compliance with art. 10, paragraph 2, of the Regulations and some eligible candidates could be admitted, the candidates admitted to enrolment who fail to pay the first instalment of tuition fees within **February 15, 2021** will be deemed as having waived their place. Such candidates will be allowed to enrol again, in case, only after all the next-ranking candidates of the list have had their own chance to enrol.

The last available date to pay the second instalment is indicated in the **Enrolment procedures** of each Advanced Professional Course at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>. To pay, students must exclusively use the customised form to be printed out from Infostud 2.0 according to the following procedure: log in to Infostud with the ID number and password from <u>www.uniroma1.it/it/pagina-strutturale/laureati</u>, select, in the following order: Advanced Professional Courses - **First year** - enter the **ID code of the course of choice** – Continue - Print. Failure to pay the second instalment within the prescribed deadline will entail the enforcement of the additional fee of \in 65 for late payment. Should the second instalment of tuition fees be paid 60 days after the deadline provided for in the call for applications, the due additional fee will be equal to the double of the standard tuition fees.

Art. 11 – REDUCTION OF TUITION FEES FOR STUDENTS WITH DISABILITIES

Students with a recognised disability pursuant to art. 3, paragraphs 1 and 3, of law of February 5, 1992, no. 104 and/or having a disability equal or higher than 66% benefit from a 50% reduction in tuition fees, without prejudice to any other reduction/exemption provided for by the **Educational activities** (art. 30, paragraph 9, of the Regulations). Recipients are therefore exempted from payment of the second instalment.

To be entitled to the above reduction, candidates must submit the certificate attesting their disability to sportellodisabili@uniroma1.it, copy to settoremaster@uniroma1.it.

Art. 12 – CONDITIONAL ADMISSION OF GRADUANDS

Graduands who are expected to achieve the degree **within the last session of the 2019-2020 academic year** and who intend to participate in this call for applications must register on Infostud according to the procedure indicated in art. 5 above and declare their status as graduands by clicking on Profile - University degrees and by ticking the "Graduand" box. Graduands must then follow the procedures to pay the admission test fees as per art. 6; they will be conditionally admitted to the Advanced Professional Course and, should a list be created, will be assigned the lowest ranking.

To duly enrol in the Advanced Professional Course, such candidates shall communicate the achievement of their degree by email to the Director of the Advanced Professional Course and to <u>settoremaster@uniroma1.it</u> within 10 days after such achievement, under penalty of forfeiture of enrolment.

They will receive by email the paying-in slip to pay tuition fees, without being charged any additional fees for late payment, within the deadline indicated on the same paying-in slip.

Candidates who did not achieve their degree at Sapienza University of Rome must also update their academic career in their Infostud profile, by clicking on "Profile – University degrees", entering the graduation date and the relating grade and by finally unticking the "Graduand" box.

Art. 13 - FUNDINGS AND/OR SCHOLARSHIPS

Fundings allocated by external institutions that have an agreement with the Advanced Professional Course may be made available to candidates by way of partial or total coverage of tuition fees. The criteria and procedures for such funding allocation are established and published by the funding institution. Any scholarships, partial or total exemptions from tuition fees already available upon publication of this call for applications are indicated in the **Educational activities** of each Course at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>.

Art. 14 - LISTENERS

Whenever the **Highlights** provide for it, supernumerary candidates who do not meet the admission requirements may be allowed to attend Advanced Professional Courses as listeners.

The tuition fees for listeners amount to 30% of the standard tuition fees for the Advanced Professional Course. To be authorised to attend Courses as listeners and to obtain the relating paying-in slip, candidates must apply to the Director of the Advanced Professional Course.

Listeners cannot be included in the minimum number of candidates required to activate Advanced Professional Courses and on no account may they participate in laboratories and stages. Upon conclusion of Advanced Professional Courses, listeners who met the minimum attendance requirement may be issued a certificate of attendance.

Art. 15 – SINGLE COURSES

Candidates may enrol in single courses of an Advanced Professional Course, whenever provided for in the **Highlights** and up to maximum 20 ECTS, provided that they hold the same entry requirement needed for admission to that Course.

Students enrolled in single courses may sit the relating exams and obtain by the Director of the Advanced Professional Course the certificate attesting the number of ECTS acquired.

In case an Advanced Professional Course were not activated, not even the relating single courses may be, unless they have been converted into Advanced Training Courses.

The ECTS acquired with single courses of an Advanced Professional Course may be taken into account when enrolling in other academic degree programmes.

The minimum amount of tuition fees for each single course is calculated according to the number of ECTS to be acquired, as indicated in art. 17, paragraph 5, of the Regulations.

To be authorised to attend a single course and to obtain the relating paying-in slip, candidates must apply to the Director of the Advanced Professional Course.

Art. 16 - WITHDRAWAL

Students of an Advanced Professional Course who intend to withdraw must send a written communication by email to the Director of that Course, available at the relating institutional webpage <u>www.uniroma1.it/it/pagina/elenco-dei-master</u> and to <u>settoremaster@uniroma1.it</u>. Tuition fees already paid, if any, will not be refunded (art. 16, paragraph 9, of the Regulations).

Art. 17 – PROHIBITION AGAINST SIMULTANEOUS ENROLMENT

In compliance with art. 142 of the Unified Act no. 1592/1933, simultaneous enrolment in more than one academic study programme is prohibited; therefore, candidates admitted to the Advanced Professional Course of this call for applications cannot enrol in any other Advanced Professional Courses, Postgraduate Schools, PhDs, Bachelor's degree programmes and Master's degree programmes in the same academic year. Such incompatibility does not apply to holders of research grants. Advanced Training Courses and Training Courses are excepted (art. 21, paragraph 1, of the Regulations).

Art. 18 – PROCEDURES FOR THE PERFORMANCE OF THE FINAL EXAM AND ACHIEVEMENT OF DIPLOMA

The performance procedures of the final exam are indicated in the **Educational activities** of each Advanced Professional Course, available at <u>www.uniroma1.it/it/pagina/elenco-dei-master</u>.

The exam is performed before an examination committee that gives a grade in one hundred tenths and may unanimously award the highest grades *magna cum laude*. The minimum pass grade is 66/110 (sixty six/one hundred tenths).

The diploma of the Advanced Professional Course is issued by Sapienza University of Rome only after the regularity of the student's administrative status has been verified; the diploma carries the grade only if honours have been awarded.

Before sitting the final exam, students must pay a € **75 fee** and fill-in the **AlmaLaurea questionnaire** according to the directions available at <u>www.uniroma1.it/it/pagina/master-prova-finale</u>.

Art. 19 – PERSONAL DATA PROCESSING

In compliance with the provisions of the EU Regulation no. 679/2016 of April 27, 2016, "GENERAL DATA PROTECTION REGULATION" on the protection of natural persons and other subjects with regard to the processing of personal data, a specific information notice is attached to this call for applications which constitutes an integral part of it.
